Students shall not use the system to encourage the use of drugs, alcohol, or tobacco, nor shall they promote unethical practices or any activity prohibited by law or Board policy. Copyrighted material shall not be placed on the system without the author's permission. Students may download copyrighted material for their use only. Students shall not intentionally upload, download, or create computer viruses and/or maliciously attempt to harm or destroy district equipment or materials or manipulate the data of any other user, including so-called "hacking." Students shall not read other users' electronic mail, nor shall they attempt to interfere with other user's ability to send or receive electronic mail, nor shall they attempt to delete, copy, modify, or forge other user's mail.
